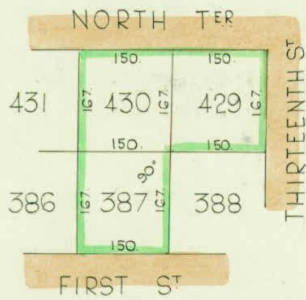

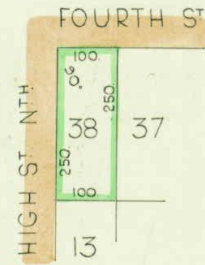




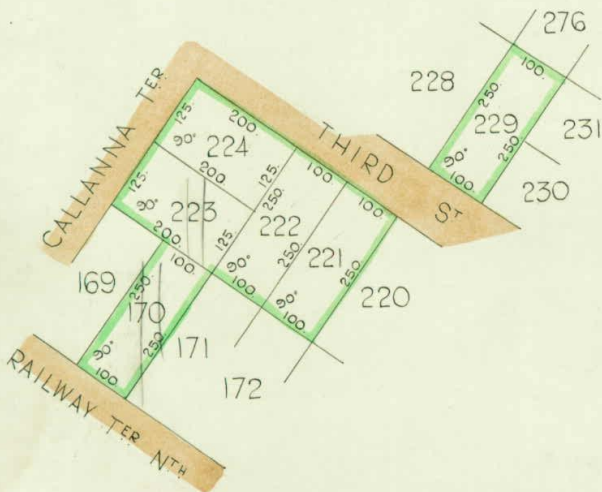
TOWN OF FARINA



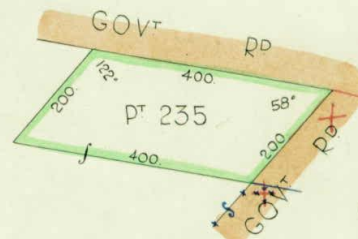
TOWN OF COCKBURN

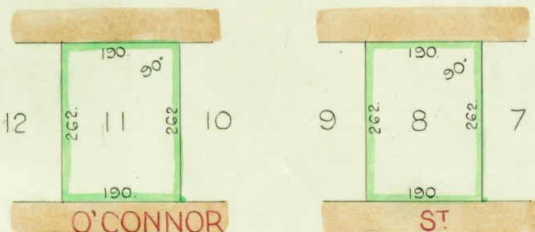

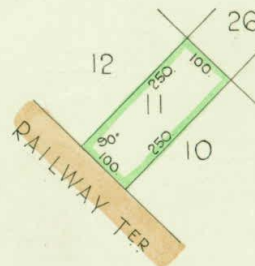
