as on the westerly side next Twelfth Street fifty five feet and two inches or thereabouts

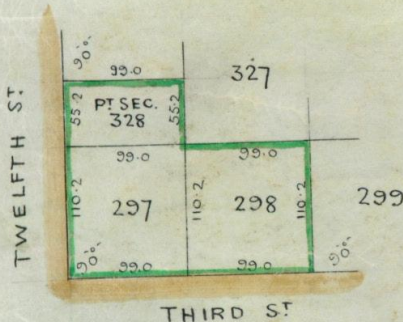
