which said Section is delineated in the public map of the said Township deposited in the office of the Surveyor-General.

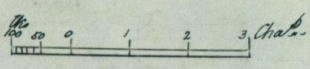
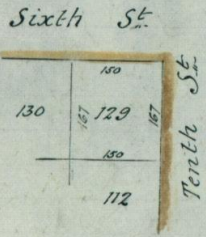
